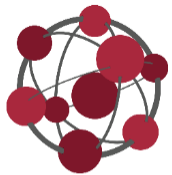

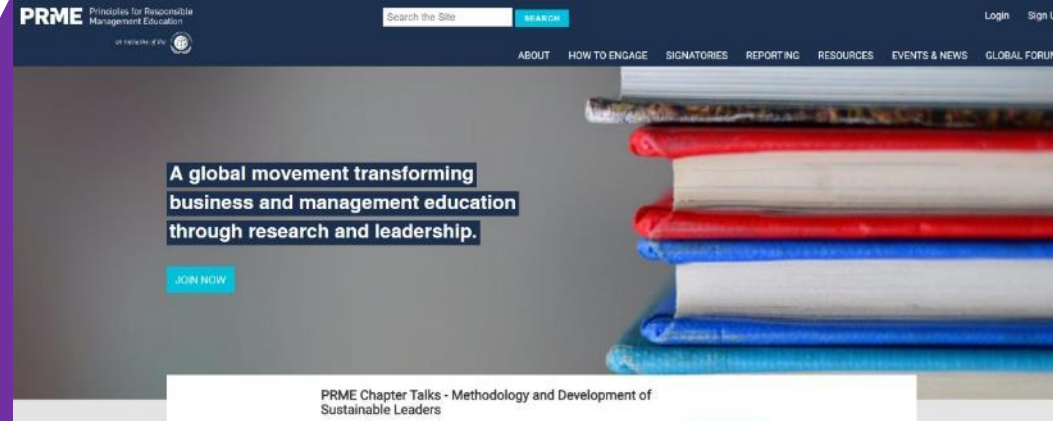

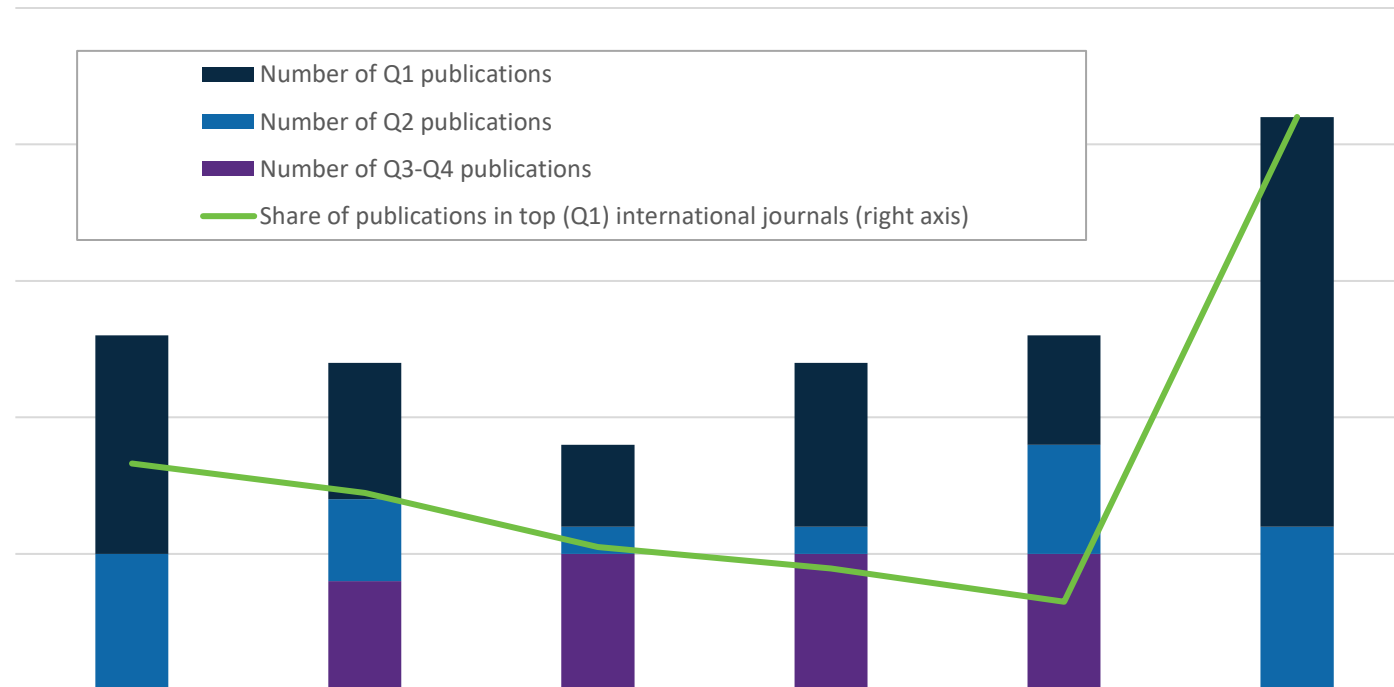
FLOW MaReTeam

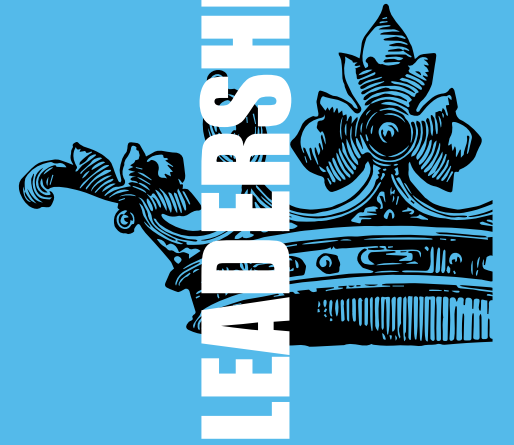

TWO DEGREES & TWO GRADUATIONS

The AM reduced tuition fee will be assessed automatically, and must be approved by the request submitted to the Study Department. For the best-performing fee-paying students (who achieve a higher credit index than the average in the particular program and semester), the Alma Mater Study Scholarship provides the opportunity to get a study scholarship/tuition fee deduction.

EARLY APPLICATION DISCOUNT

Early Application Discount can be given to those applicants who apply until 15th March for BSc programmes and 20th August for MSc programmes (registering for the given year in the case of BSc and registering for the upcoming year in the case of MSc students). It is the tuition fee's 20%.

TALENT DISCOUNT

Talent Discount is offered to the best student applicant on each programme based on application scores. It is the first semester's tuition fee's 50%.

BEST STUDENT AWARD

This award is given at the end of each year to the student who is getting the letter of commendation of their programme (1500 EUR). SH Scholarship holders are also eligible for this scholarship.

STUDENT STUDY EXCELLENCE SCHOLARSHIP

The scholarship is based on the weighted average of the student's last completed active semester in Neptun and the maximum amount that can be given is 1150 EUR. SH Scholarship holders are also eligible for this scholarship.

STUDENT RESEARCH EXCELLENCE SCHOLARSHIP

This scholarship is giving to those students who are showing the best research performance each semester. SH Scholarship holders are also eligible for this scholarship.

This year our School has successfully extended its programme accreditation awarded in 2020, as the first countryside university in Hungary, by the EFMD, one of the most prestigious organisations for the qualification of international business management programmes.

Our program accreditation is based on five strong pillars, the already mentioned programme label, secondly the global recognition which provides us an international market recognition, thirdly the international benchmarking – by being compared with other institutions and reviewed by an international peer review team.

The forth pillar is the strategic advice and guidance as well as institutional development which guides us for outstanding quality improvement.

And finally we became the part of the international learning community, facilitating the sharing of good practice.”

APPLICATION PROCESS IN A NUTSHELL

International applicants use the School's online application platform (<https://apply.pte.hu/>), through which the application process is the following:

1. The applicant uploads all the required documents on the online application platform;
2. After submitting the documents, the applicant receives an official invoice of the application fee;
3. After the payment of the application fee, the uploaded materials are evaluated and the decision is made whether the applicant is eligible or not;
4. If eligible, we conduct the Mathematical test (BSc level)
5. An oral interview (personal or online) is scheduled with eligible applicants and carried out by a committee;
5. Based on the applicant's academic qualification, motivation letter and the oral interview a decision is made on acceptance;
6. Selected applicants receive an offer invoice of the first semester's tuition fee;
7. Accepted students receive their official Letter of Acceptance after paying the tuition fee for the first semester of their studies.
