Evaluation of the achievement of quality objectives set for the period until 31 August 2021

Honourable Faculty Council,

in accordance with Par. 8. (3) e) of the quality management system of the University of Pécs, "the evaluation of meeting the quality objectives set is made by the Quality Development Committee at university level, and by the quality control committees of the respective faculties and the Clinics Centre, on an annual basis"

The deadlines of the accomplishment of each quality objectives specified by the Faculty of Business and Economics on 16 September 2020 expired on 31 August 2021, making it necessary to evaluate the meeting of the quality objectives.

Evaluation of the achievement of quality objectives:

1. Improvement of the recognition of the international studies of the students of FBE by the Faculty recognition system inaugurated in 2019

This Quality Objective was set for the second time, due to the fact that some of the study trips abroad by students in the 2019-2020 school year were made impossible by the travel restrictions imposed as an effect of the Covid pandemic, and so this objective could not be met at that time: it was 2.3% below the base value. Unfortunately, similar restrictions were imposed in the year 2020-2021. According to the data of the Study Department, a total of 12 subjects accomplished abroad were recognised; due to this fact, an evaluation can only be made with reservations.

Base value (2019/2020): 56.3% Actual figure measured (2020/2021): 75% (9 subjects recognised as A+B subjects, 3 subjects recognised as C subjects)

The quality objective was met numerically, but the evaluation of the quality objective can only be done with reservations, because of the small sample number.

2. Continuation of the infrastructure development of the Faculty and its extension to technical developments serving modern (hybrid) teaching

The Faculty implemented building renovations in the 2020/2021 school year, the most important of which were the installation of a touch-free entrance door and the start of the renovation of the sanitary facilities until 31 August 2021. The teaching methods changed as an effect of the pandemic also necessitated infrastructure development; the relevant quality objective in this field was the development of technical devices in rooms used for hybrid education.

The indicators on the basis of the quality objective are as follows:

- Number of projects launched (touch-free entrance door, sanitary facilities, court), target value: 1
- Number of rooms with technical devices used for hybrid education, target value: 4

At the transformation for hybrid teaching, rooms B312, B314 and B025 were equipped with 4K cameras, 2 in each of the latter two. Also, in rooms B314 and B025 sound systems were completely replaced. Several smaller rooms were also involved in the support of hybrid education with the special cameras installed, which proved to be a good solution for rooms with up to 40-50 student capacity. On the whole, full development was implemented in rooms B312, B314 and B025.

3. Development of the measurement of students' satisfaction (OMHV) at the Faculty

A new university level regulation of the measurement of student satisfaction was approved in the 2019/2020 school year by the Senate of the University of Pécs, which affects, among other things, the composition of the Faculty's OMHV committee and the structure of the questionnaires to be used. Parallel to this, the acquisition of the international accreditation for the English language BSc programme of the Faculty also made it necessary to develop and standardise the system used for the students' evaluations.

The Faculty's Quality Management and OMHV Committee approved on their meeting on 11 November 2020 the new OMHV questionnaire meeting the requirements of Appendix 11 of the Organisational and Operational Regulations of the University of Pécs (regulation on the order of the OMHV), which is standard and can be used for both the Hungarian and the English language programmes of the Faculty. When designing the questionnaire, it was important to have one comparable with the assessments made with the former Hungarian language questionnaire used in the Faculty, and so questions that had been used before were also integrated into the new questionnaire. Another important criterion was to meet the requirements by the Performance Evaluation System, which means the creation of one complex index for each lecturer in each seminar.

For PhD programmes a separate questionnaire was made, in accordance with the relevant regulation of student evaluation of the University of Pécs, which is not part of the index of the Performance Evaluation System.

The new questionnaires were applied in evaluations by students in the autumn and spring semesters of the 2020/2021 school year.

The indicator of the quality objective: having a single Faculty student evaluation (OMHV) system that is compatible with the university's OMHV regulation, and is standard for both Hungarian and English language programmes. Value expected: 1.
