Evaluation:

The Faculty submitted the EFMD Self-Assessment Report on 17 July 2024, which was approved by the EFMD Office on 30 July 2024 after several consultation rounds.

The Faculty uploaded the documents required to obtain AACSB eligibility status via the official platform on 14 December 2023, and the positive decision necessary to initiate accreditation was officially received from the committee on 23 February 2024.

The new Expected Learning Outcomes were not published, therefore the fulfillment of the quality goal became obsolete. There was no comprehensive curriculum renewal.

Objective: New Performance Appraisal System rules issued as a Dean's instruction.

Evaluation:

Dean Instruction no. 1/2024. contains the updated faculty Performance Appraisal System (Hungarian abbreviation: TÉR) (version 4.1), which was issued in the form of a Dean's instruction, including regulation for researchers, as well as a much more detailed regulation of World of Practice (WOP) and science organization activities, and a teacher/researcher classification system compatible with the AACSB system.
