# Quality Objectives of the Faculty of Business and Economics (FBE) for the Period Ending 31 August 2026

Based on the professional recommendation of the Faculty Quality Management and Student Feedback Committee, as Dean of the Faculty of Business and Economics (FBE), I designate the following quality objectives for the 2025/2026 academic year.

# 1. Quality Objective: Successful Accreditation of Doctoral Schools

### Background of setting the quality objective:

At its meeting on 25 June 2025, the Senate of the University of Pécs decided to set the following university-level quality objective (UP Quality Objective No. 4) to be achieved by 31 December 2025: "Preparation of the self-assessment reports and successful management of accreditation visits, obtaining accreditation for all doctoral schools concerned."

Since both doctoral schools operating at the Faculty — the Doctoral School of Business Administration and the Doctoral School of Regional Policy and Economics — are involved in the reaccreditation process and explicitly named in the university-level objective, it is appropriate to adopt this goal also at faculty level.

## Specification of the quality objective:

Extension of the accreditation of both doctoral schools operating at the Faculty (Doctoral School of Business Administration and Doctoral School of Regional Policy and Economics) by the Hungarian Accreditation Committee (MAB).

# 2. Quality Objective: Launching the AACSB Institutional Accreditation Process

#### Background of setting the quality objective:

According to the Faculty's 2023/24 quality objectives, the documentation required for obtaining AACSB eligibility status was officially submitted via the AACSB platform on 14 December 2023. The positive eligibility decision from the AACSB Initial Accreditation Committee was received on 23 February 2024. The final deadline for submitting the Initial Self-Evaluation Report (iSER) is 1 December 2025; however, the Faculty submitted the iSER on 1 September 2025. Based on this report, the AACSB Board will decide on the initiation of the accreditation process, which will provide a three-year timeframe for the submission of the final Self-Evaluation Report (SER).
